

AUSTIN CITY COUNCIL MINUTES

WORK SESSION MEETING TUESDAY, AUGUST 1, 2017

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, August 1, 2017 City Hall at 301 W. Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 9:08 a.m.

COUNCIL ITEMS OF INTEREST

Mayor Adler introduced the agenda for the August 3, 2017 Council meeting and allowed Council to give input or ask questions on any item posted on the agenda. Staff was available to provide verbal responses to Council questions. Discussion was held on the following items taken from Thursday's agenda.

- 50. Approve an ordinance amending City Code Chapter 14-4, relating to the regulation and permitting of sidewalk cafes.
- 51. Authorize negotiation and execution of a professional services agreement with TOOLE DESIGN GROUP, LLC. (staff recommendation), or one of the other qualified responders to the Request for Qualification Solicitation No. CLMP229, to provide engineering services for Street Design Staff Augmentation for an initial two-year term, with four renewal options, for a total contract amount not to exceed \$6,000,000 including all renewals, subject to annual appropriations. (Notes: This contract will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program). No goals were established for this solicitation.)
- 56. Approve a resolution directing the City Manager to initiate the process of renaming "Water Treatment Plant 4" to the "Berl L. Handcox, Sr. Water Treatment Plant." (Notes: SPONSOR: Council Member Jimmy Flannigan CO 1: Council Member Ora Houston CO 2: Council Member Sabino "Pio" Renteria CO 3: Mayor Steve Adler)

BRIEFINGS

B.1 Aquatics Master Plan Briefing

The presentation was made by Kimberly McNeeley, Acting Director, Parks and Recreation Department; Jodi Jay, Division Manager, Parks and Recreation Department; and Reynaldo Hernandez, Master Plan Project Manager, Parks and Recreation Department.

Direction was given to staff to provide Council with the following: a copy of the agreement between the City and the City of Round Rock regarding the Canyon Vista pool; a map with information regarding how many community pools would be created with the \$96 million; the 2012 Aquatic Facilities Comprehensive Master Plan Resolution; and information on the amount of funds lost through Council fee waivers, a list of programs generating funds that go directly to the general fund, and recommendations on what Council can do to assist the department to keep the money raised through fees.
