

## M/WBE Summary

Public notice was given for this solicitation CLMC638 ADA Sidewalk and Ramp Improvements for Safe Routes to Schools, N Lamar Blvd, Burnet Rd IDIQ, through the City's Vendor Connection web portal, which resulted in 435 contractors receiving notification and 79 contractors obtaining bid documents. Six bids were received and opened on June 8, 2017. Of the six bids, received two bids were from MBE/WBE certified firms. Muniz Concrete & Contracting, Inc. submitted the lowest responsive bid of six bids received:
