## **MINUTES**

### **A. CALL TO ORDER**

Chair Rivera called the meeting to order at 6:02 p.m.

Chair Rivera made a correction to the board members listed on the meeting agenda and added a newly appointed District 8 Board Member Mary Katherine Stout.

### **B. APPROVAL OF MINUTES**

#### **1. Approve the minutes of the Parks and Recreation Board meeting of July 25, 2017.**

Vice Chair DePalma made a motion to approve the minutes of the Parks and Recreation Board regular meeting of July 25, 2017. Board Member Donovan seconded the motion. The motion carried on a vote of 7-0 with Board Member Casias abstaining, and Board Member Farasat, Morgan, and Stout absent.

### **C. CITIZEN COMMUNICATION**

**Leon Hernandez**, addressed the Board and voiced his concern about the use of Parque Zaragoza as a temporary shelter for individuals experiencing homelessness.

**Gavino Hernandez**, spoke to the Board and also voiced his concern about the use of recreation centers for shelters for individuals experiencing homeless and advocated for more programming.

**Helen Miller**, spoke to the Board and also expressed her concern about the use of recreation centers Rosewood and Zaragoza for homeless shelters. Ms. Miller voiced her concern about and

programs being taken away for children.

**Barbara Scott, Colony Park Neighborhood Association**, spoke to the Board against using recreation centers for sheltering individuals experiencing homeless and expressed her concerns about children and children programming.

Chair Rivera moved items 5., and 6. before items 2., 3., and 4.

## **F. NEW BUSINESS: BRIEFING AND DISCUSSION ITEMS**

### **5. Briefing and discussion to introduce the “Stronger Austin” partnership between Austin Parks and Recreation, Austin Public Health, and It’s Time Texas**

Lucas Massie, Acting Assistant Director, Parks and Recreation Department, and Baker Harrell, It’s Time Texas, made a presentation to the Board regarding the Stronger Austin partnership including educational and recreational opportunities and answered Board Members’ questions.

### **6. Briefing and discussion regarding recycling in City of Austin parks**

Liana Kallivoka, Assistant Director, Parks and Recreation Department, made a presentation to the Board regarding the recycling efforts and challenges at the Parks and Recreation Department parks and facilities. Assistant Director Kallivoka and Richard McHale, Interim Assistant Director, Austin Resource Recovery, answered Board Member’s questions.

Chair Rivera nominated Board Members Cofer and Lewis, Vice Chair DePalma and Chair Rivera, to serve on the Aquatic Master Plan Task Force. All nominated accepted the nominations. The motion was made by Vice Chair DePalma and seconded by Board Member Mann.

The motion carried on a vote of 8-0 with Board Member Farasat, Morgan, and Stout absent.

**John Rooney**, Programs Coordinator, Austin Parks Foundation, commended the work Parks and Recreation Department staff and stakeholders did during the Master Plan creating process and offered assistance of the Austin Parks Foundation with the process.

### **4. Discussion on council direction regarding the Aquatic Master Plan Task Force**

Kimberly McNeeley, Acting Director, Parks and Recreation Department, informed the Board on the Council direction and council resolution no. 08172016-52 regarding the Aquatics Master Plan Task Force and answered Board Members' questions. Acting Director McNeeley discussed the process and logistics of the process and offered staff help with the assigned tasks.

Discussion was held on the he Aquatics Master Plan Task Force.

**Alan Pease**, Aquatic Advisory Board, addressed the Board, provided his input on the Aquatic Master Plan, and made suggestions regarding the Aquatic Master Plan evaluation process.
