- Ms. Price confirmed that data on community trends can be accessed on 211's website.
- Ms. Price stated that the data on the needs and locations of residents 65+ has been shared with the Commission previously and will be circulated following the meeting.
- Ms. Price explained the 211 data collection training process, which occurs quarterly but can be tailored to the needs of trainees.
- B. Presentation and discussion regarding senior housing and multi-generational program (Amy Wong Mok, Asian American Cultural Center)
 - Ms. Mok explained that there are three acres of land under management of the Asian American Cultural Center, only 20% of which is currently being utilized. Ms. Mok proposes to build an affordable senior living center, which will create a multigenerational use for the facility. The building will have one and two bedroom units.
 - The eligibility criteria for residing at the facility is twofold: the head of household must be 55+, and of Asian descent. If there are additional units available after satisfying the demand from the Asian community, it will be opened up for other senior communities.
 - Ms. Mok requested that the Commission on Seniors provide a letter of support for the use of the land, as proposed, which requires modifications to building code.
 - Chair Briesemeister informed Ms. Mok that the Commission will follow up with her regarding a potential letter of support, as the Chair and Commission have outstanding questions.
