Chapter 252 of the Local Government Code requires that municipalities comply with the procedures established for competitive sealed bids or proposals before entering into a contract requiring an expenditure of \$50,000 or more, unless the expenditure falls within an exemption listed in Section 252.022.

Senate Bill 7 amended Chapter 252 of the Local Government Code to exempt from the requirements of such Chapter expenditures made by a municipally owned electric utility for any purchases made by the municipally owned electric utility in accordance with procurement procedures adopted by a resolution of its governing body that sets out the public purpose to be achieved by those procedures. The Austin City Council has adopted Resolution No. 040610-02 to establish circumstances which could give rise to a finding of critical business need for Austin Energy.

This Certification of Exemption is executed and filed with the Purchasing Office as follows:

Airbus Helicopters, Inc., is the only approved source of supply for Airbus Helicopters parts for North America. They provide originating paperwork and require FAA forms in addition to insuring shelf life limited parts and factory warranties are maintained within prescribed standards. This would include factory overhauled parts, which are warranted from the date of delivery to the original purchaser. Therefore all replacement parts for the H120 & H125 must be purchased through Airbus Helicopters, Inc.
