1. CITIZEN COMMUNICATION: GENERAL

Note: Although citizen communication is generally reserved for items not on the agenda, a special dispensation was made in this case given the large number of people wishing to comment on the street design item..

- Mateo Barnstone: called for more public process in advance of City Council consideration of local amendments to the International Fire Code.

- Barbara Scott: expressed concern that requiring wider streets than are currently proposed for the Colony Park Master Plan would reverse six years of work done by the Northeast Austin community on the plan.
- Dan Keshet: expressed concern about safety and walkability implications of wide streets.

B. Street Design and Public Safety (Austin Transportation Department and Austin Fire Department) – Briefing
