

URBAN RENEWAL BOARD DRAFT MINUTES

SPECIAL CALLED MEETING August 21, 2017

The Urban Renewal Board convened in a special called meeting on Monday, August 21, 2017, at the Street-Jones Building, 1000 East 11<sup>th</sup> Street in Austin, Texas.

An Urban Renewal Plan's primary purpose is to eliminate slum and blighting influence within a designated area of the city.
