Pursuant to section 4-8-12 of the Austin City Code, the City Attorney submits this report to the Audit and Finance Committee related to compliance and enforcement of Chapter 4-8 Regulation of Lobbyists) of the City Code (referred to as the Lobbying Ordinance).

The amended Lobbying Ordinance took effect June 1, 2017. The quarterly reporting deadlines are established in the City Code and the first deadline following the effective date was July 10, 2017.
