1404 W. 9TH STREET WEST LINE HISTORIC DISTRICT

PROPOSAL

Demolish a ca. 1923 house.

ARCHITECTURE

One- and two-story rectangular-plan, front-gabled frame bungalow with a two-story, side-gabled addition to the rear. The original house has a partial-width, semi-inset porch on square wood posts and stuccoed piers; single, paired, and triple 6:1 fenestration with matching window configurations in the second-story addition to the rear.

RESEARCH

The original part of the house was built in 1923 by Albert and Ethel Dearing, who lived here off- and on until around 1958, Albert Dearing was a native of south Travis County, where he grew up on a farm on Manchaca Road. He moved into Austin by 1917, and was working as a motorman for the Austin Street Railway Company. By 1920, according to the census report, Albert and Ethel Dearing were living on W. 12th Street. Albert Dearing worked as an auto mechanic. They lived in this house from around 1923 to around 1925, and around 1928 to around 1930, with renters filling the intervals. The Dearings were living in San Antonio in 1930, but returned to this house in 1936. Albert Dearing is listed in city directories as a building contractor, welder, and a weather-stripping contractor for the time that he and Ethel lived here. They remained here until around 1958.

The house was vacant in the early 1960s; city directories from that time forward show a history of rentals.


STAFF COMMENTS

The house is contributing to the West Line Historic District.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, including consideration of the demolition delay authorized by Code, as the house is contributing to the historic district. If the Commission votes to release the permit, then staff recommends the completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history for archiving at the Austin History Center.

BIOGRAPHICAL NOTES

Albert and Ethel Dearing (ca. 1923 – ca. 1925, ca. 1928 – ca. 1930, and ca. 1936 – ca. 1958) Albert Dearing appears in the 1910 U.S. Census as the 19-year old son of Jake and Frances Dearing, who lived on a rented farm on the Manchaca Road in Travis County. Albert had been born in Texas, and was a laborer on the home farm. His father, Jake Dearing, 55, had been born in Texas to German-born parents, and is listed as a farmer. Albert's mother, Frances Dearing, 44, had also been born in Texas to German-born parents. She had no occupation listed. Albert had an older brother, Charles, 23, a Texas-born farm laborer, and two younger siblings, Joseph, 17, a Texas born farm laborer, and May, 16, who had been born in Texas and had no occupation listed.

His 1917 World War I draft registration card shows that Albert Dearing was living at 1504 W. 8th Street in Austin. He was born in 1890 in Big Springs, Texas, and was a motorman for the Austin Street Railway Company. He was married, and had served as a corporal in the Cavalry of the Texas State Guard. He was of medium height and build, and had auburn hair and blue eyes.

Albert and Ethel Dearing appear in the 1920 U.S. Census as the renters of the house at 1111 W. 12th Street in Austin. Albert Dearing was 29, had been born in Texas, and was an auto mechanic. Ethel Dearing was 21, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1930 U.;S. Census shows Albert and Ethel Dearing as the renters of a house in San Antonio. Albert Dearing was 40, had been born in Texas, and was a foreman for a welding company. Ethel Dearing was 32, had been born in Texas, and had no occupation listed. They had 2 sons: Howard L., 10, who had been born in Texas; and Fred L., 3, who had been born in Missouri.

The 1940 U.S. Census shows A. and Ethel Dearing as the owners of this house, which was worth \$3,000. A. Dearing was 50, had been born in Texas, and was a building contractor. Ethel Dearing was 42, had been born in Texas, and had no occupation listed. They had 2 sons: Howard L, 20; and Fred L., 13. Both boys had been born in Texas, and neither had an occupation listed. With them lived Ethel Dearing's mother Margaret Prewitt, an 81-year old Texas-born widow with no occupation listed.

Albert Dearing

Albert Dearing, 94 of Austin, died Thursday.

He was a member of First Cumberland Presbyterian Church for sixty years.

Puneral services will be held at 3:00 PM. Saturday, in the Colonial Chapel of the Cook-Walden Funeral Home, with Dr. Loyce Estes officiating. Interment will be in Austin Memorial Park Cemetery.

Mr. Dearing was the husband of Ethel Dearing of Austin; father of Fred L. Dearing of Austin; grandfather of Howard R. Dearing of Austin, Linda Hyatt of Lampasas; great-grandfather of eight; brother of Raymond Dearing of Austin.
