Leane,

My name is Cheryl W Grossman and for nearly forty years I have lived in one of the neighborhoods near the Life Austin Church campus (8901 SH 71 West, 78736). This area of West Oak Hill is zoned rural residential. I am completely baffled as to how what is essentially a commercial outdoor concert venue got approval from City Neighborhood Planning and Zoning...apparently done without public hearings/notifications and under the guise of religious assembly. We are established neighborhoods in which amplified, live outdoor performances are incompatible on every level.

At a meeting several years ago, after construction was already underway, church leaders met with neighbors at a meeting hosted by Oak Hill Association of Neighborhoods. Despite assuring the gathered neighbors that the church intended to monitor the sound with care and to address traffic concerns on Highway 71 West, the church has delivered a very different reality. Neighborhoods closest to the church have been negatively impacted by unwanted amplified performance and traffic has been negatively impeded. Neighborhoods not contiguous to the church have also been disturbed by the noise. My neighborhood, as a member of OHAN, has voted in favor of the multiple resolutions supporting Hill County Estates HOA and Covered Bridge POA.

Despite assurances that the ampitheater would be used on a limited basis for religious assembly, here is the reality in a recent mailing: Life **Austin Ampitheater** has scheduled 3 performances (2 music, 1 dance) this month. And yes, in the most recent mailing Life **Austin Ampitheater** is exactly how this concert venue is being marketed. How does this fit with religious assembly? The church has essentially deprived neighbors of the full use of their own property in order to stage concerts. Those of us who live in this rural residential neighborhood do not want to see this usurpation set a precedent.

I support the appeals filed by Hill County Estates HOA and Covered Bridge POA as well forwarding the appeal to the Board of Adjustment.

Hello, Ms. Heldenfels. I was present at the BOA December 9 meeting, the end result of which was the BOA's postponing until February and also requesting the neighborhoods and LifeAustin to work together to find a compromise solution. I would like to use my own comments and story points to emphasize that "finding a compromise" is exactly what the neighborhoods have been diligently trying to do—and thwarted in these efforts, by both the City and LifeAustin—since 2007.

- In April 2007 I was a Board member in Hill Country Estates Homeowners Association. At my initiation and invitation, Randy Phillips stood in my living room the evening of April 21, 2007 for his first meeting with a small group of residents from Hill Country Estates, Covered Bridge, and Westview Estates. Phillips had no idea of the City's ongoing Oak Hill Neighborhood Planning process, and he told us of his plans for the nearby tract of land to encompass a very large sanctuary and a very large outdoor amphitheater (as well as walking trails, sports facilities, and counseling centers, to name just a few). The neighbors were welcoming of Phillips and his church but expressed concern about issues of sound, lighting, and traffic. At that very first meeting, we suggested that Phillips consider enclosing the amphitheater. Many subsequent meetings were held among the neighborhoods and LifeAustin representatives through 2007, 2008, and 2009. I am quite certain that at every single one of those meetings, compromises were proposed and discussed.
 - On August 7, 2008 John Donisi (attorney at that time for LifeAustin) sent an email to me giving us his "personal commitment that if and/or when this or any other filing at the City of this nature is contemplated by [LifeAustin], we would certainly let the group know." (This concerned LifeAustin's withdrawal of their request for a height variance.) This commitment was not upheld by Mr. Donisi, nor was it ever honored or given by any subsequent attorneys or representatives for LifeAustin.
 - On January 12, 2009, at a meeting in my living room between representatives of the 3 neighborhoods and LifeAustin, the message expressed to the neighborhoods was that, while LifeAustin would like to have the neighborhoods' approval and acceptance of their entire project (including the outdoor amphitheater), our approval wasn't in fact needed because of the religious nature of the project. [Note: these are my own words expressing the message imparted to us by their representatives at that meeting.]
 - On April 10, 2010, I was told by LifeAustin legal representative(s) that we had not heard from them because there was nothing new to report.

 On January 27, 2011 I received via US Mail a City of Austin "Notice of Filing of Application for Administrative Approval of a Site Plan" for the proposed LifeAustin development. Not one of the neighborhood representatives received any communication from any LifeAustin representative regarding the filing of this Application.

As you and the Board members recognize, over the past 5 years this has become a very complex situation, made all the more so by City staff actions. I cannot stress strongly enough to your BOA members that, from the outset, the neighborhoods have taken the initiative for meetings, have been open and accessible, and have sought to work with Randy Phillips and LifeAustin representatives to find reasonable solutions. And the neighborhoods continue to do so, even today.

Board of Adjustment HEARING: LIFE AUSTIN OUTDOOR AMPHITHEATER

Residents who live in neighborhoods surrounding the LifeAustin outdoor amphitheater have expressed their concerns and opposition to the outdoor amphitheater for more than seven years. Two neighborhoods filed appeals regarding some of the unprecedented determinations made by city staff that allowed the outdoor amphitheater to be built.

It's important to note that under City code, *if a building permit or certificate of occupancy is determined to have been issued in error, it can be suspended and reversed by the City of Austin Board of Adjustment (BOA) regardless of the stage of building that has occurred.* LifeAustin and its pastor, Randy Phillips, were <u>personally</u> informed and in writing about this possibility well before they broke ground on building the outdoor amphitheater. Instead, they built the amphitheater and <u>assumed the risk</u> that they might not be able to use it in the future.

A hearing before the BOA is set for **November 9, 2015**; however, the neighborhoods have asked for a **postponement to December 9, 2015**. Background Facts

· In May 2015, Court of Appeals overturned trial court decision as to HCE HOA. Court of Appeals' opinion said that trial court cannot decide standing to sue until BOA first decides standing issue.

City's Approval of Outdoor Amphitheater Building Permit

- · HCE HOA and CB POA filed appeal of City's and Guernsey's "interpretation" approving a building permit for LifeAustin's outdoor amphitheater.
- · Staff refused to forward building permit appeal to BOA.
- · In late 2012, staff sought an amendment to City Code Section 25-2-921(C) to authorize the building official to issue temporary use permits (TUP) in all residential zoning districts for outdoor benefits and festivals held on property used for education and religious assembly purposes.
- · In November 2013, staff issued a new interpretation of Section 25-2-921(C) in a memo that said, due to non-enforcement, this code section no longer prohibits outdoor benefits and festivals on church and school property.
- · HCE HOA and CB POA filed appeal of City's and Guernsey's "interpretation" of the TUP in December 2013 ("TUP Appeal").
- · Staff refused to forward TUP Appeal to BOA claiming the November 2013 interpretation did not contain any "appealable" decisions.
- · Since November 2013, outdoor benefits and festivals held on property used for education and religious assembly purposes has been allowed as interpreted in the November 2013 memo.

Two of Three Appeals Now Allowed to Proceed

· Staff agrees to send site plan and building permit appeals to BOA but not TUP Appeal.

Primary Appeal Issues for Site Plan and Building Permit Appeals

· Director Guernsey approved the outdoor amphitheater as a religious assembly use. He said the zoning code did not make a distinction between indoor and outdoor religious assembly. This is incorrect. Section 25-2-921(C) of the zoning code prohibits all outdoor assembly (public, historic and religious), including benefits, festivals and other events likely to attract a mass gathering of people in the RR to SF-3 zoning districts. The LifeAustin property is zoned RR.
