- Recommendation to include dual language: end curfew (11pm-6am) or let expire for adolescents under 18 whereas the Immigrant Communities detention can lead to immigrant enforcement.

  - o Approved by 11-0 vote with Aditya Rastogi absent
- Adopt recommendation as amended
  - Motioned by Karen
  - o Seconded by Sam
  - o Approved by 11-0 vote with Aditya Rastogi absent
