ACTIONS ALLEGED TO BE A VIOLATION:

Special exemption privilege for the Salvation Army (TSA). APD has given the Salvation Army (TSA) an exemption and special privilege by not properly classifying, investigating, charging, or labeling crimes committed by staff, TSA contractors or approved by TSA director Jay Filderman. As a result, I was not kept safe from harm and neither were other clients especially female. This empowered staff to continue harmful activities with impunity. On 03/31/1963, I crashed APD HOST meeting, TSA Director Jay Filderman was sitting at head of table with HOST officers Trejo and Borton. In 2017, Filderman personally threatened me on multiple occasions for witnessing unsafe conditions at TSA while COA gave him pass.

Duty of APD to keep all of Austin public safe. TSA is city contractor (Austin Shelter for Women and Children).

About 3-28-17, APD officer claimed I was committing crime by wearing an "Army" t-shirt. I believe the only reason I was not charged was because I did not answer the officers questions. Thus, not giving him enough information to arrest me, I have lost many jobs because I called APD to report crime and was punished by having fake charges against me which meant lost time at work, I became homeless after I called APD at the direction of SAFEPLACE. The officer told the perp to evict me. One case of many of APD amplifying the trivial to create a reason to arrest or charge me. I believe APD is being used to push blacks out of this community by working backwards on the ECHO barriers to housing list. WITNESSES OR EVIDENCE THAT WOULD BE PRESENTED: Manley's inaction. Video of officer trying to get me to confess when I have done nothing wrong. Friend later pointed out that he has video of people being beat up for really stealing valor. Officer slandered me by saying I had done this and put me in danger. APD officer job description. I laughed before I knew how serious it was to be falsely accused of this. Lack of an apology by APD condones action & behavior by officer. APD drafted me into "Army" by denying me equal protection now I was being punished for embracing it. I walked outside and reported this to outside APD on 1-9 and 1-10. Both days told to go to report this to TSA Director

Jay Filderman. APD refused to take report both days. When I spoke to Director Filderman who threatened my housing.

Filderman allowed Burleson to live in women's dorm again and where continued to prey on female clients. He was exited
quietly. This made it appear that Salvation army is was safe environment. APD is place for citizens to report suspected
crimes and suspicious activity not Director of Salvation Army.
