1. CITIZEN COMMUNICATION: GENERAL

2. APPROVAL OF NOVEMBER 6 MEETING MINUTES

4. ITEMS FROM PAC

B. Discussion PAC subcommittee structure and appointment of subcommittee chairs – Discussion and Possible Action

Staff liaison Emily Smith presented <u>draft language</u> for a bylaw amendment that would remove the current requirement for full members of the PAC to belong to one of two standing subcommittees (the Technical Subcommittee and Project Subcommittee), but still allow for as many ad-hoc PAC subcommittees as needed to be formed to develop recommendations to bring back to the full PAC.

No action taken. Chair Branigan Mulcahy appointed Patricia Schaub to convene a subcommittee to further discuss potential changes to the PAC's subcommittee structure.

C. Street Design and Public Safety recommendations – Discussion and Possible Action

PAC members Branigan Mulcahy, Carly Haithcock, Jay Blazek Crossley, Adam Greenfield, Kelsey Veazey, Justin Henderson, and Wallis Goodman met on November 15 to develop draft recommendation language for the full PAC's consideration which, after debate and amendment, read as follows:

"NOW, THEREFORE, BE IT RESOLVED, the Pedestrian Advisory Council recommends that:

- 1. In the drafting of any City of Austin amendment to the International Fire Code, factors that are known to negatively impact pedestrian safety should not be included, and therefore Sections 503.2.1, 503.2.2 and 503.2.4 should be **intentionally omitted** from the proposed Amendment.
- 2. Stakeholders in the public process should include the Vision Zero Task Force, the Pedestrian Advisory Council, et al. as determined by the City Manager.
- 3. Any City of Austin Amendment to the International Fire Code that impacts urban design and/or pedestrian safety (e.g. Section 503) should be reviewed and approved by a cross-departmental process.
- 4. The public process should consider adding language to the City of Austin Amendment to the International Fire Code that specifies a decision making hierarchy when differences occur between the provisions of the City of Austin's amendment to the International Fire Code and other adopted City of Austin policies, including the Transportation Criteria Manual or the Vision Zero Action Plan."

Action taken: A motion to approve the recommendation as amended passed unanimously (9-0) on Girard Kinney motion, and Heyden Walker second. The <u>recommendation</u> can be found on the PAC's <u>webpage</u>.

D. Capital Metro Downtown Station recommendations – Discussion and Possible Action

PAC member Sarah Gable submitted draft recommendation language for the full PAC's consideration which, after debate and amendment, read as follows:

"NOW, THEREFORE, BE IT RESOLVED, the Pedestrian Advisory Council recommends that the City of Austin, Capital Metro, and their consultants work closely with the Design Commission to review the design for

the new Downtown Station and adjacent plaza within Brush Square, and receive appropriate design feedback, considering the following:

- 1. The pedestrian experience should be carefully considered to ensure function and safety, as well as the creation of a cohesive design which is enjoyable and engaging to pedestrians.
- 2. There should be robust pedestrian connectivity from Plaza Saltillo to Trinity Street, a separate pedestrian walkway from the bikeway, and a walkway on both sides of Fourth Street.
- 3. The design should allow for future extension of the rail line west, notably to Seaholm.
- 4. There should be an appropriate construction detour for pedestrian mobility, including ADA access and wayfinding for the vision impaired"

Action taken: A motion to approve the recommendation as amended passed unanimously (6-0) on Heyden Walker motion and Patricia Schaub second with Carly Haithcock, Katie Deolloz, and Girard Kinney absent for the vote. The recommendation can be found on the PAC's webpage.
