Public notice was given for this solicitation CLMC575 Sabine Street Promenade through the City's Vendor Connection web portal. Three bids were received and opened on October 15, 2017. Of three bids received one bid was from a DBE certified firm. DeNucci Constructors, LLC submitted the lowest responsive bid of three bids received including allowances in the amount of \$80,000:
