Public notice was given for this solicitation CLMC680 Slaughter Creek Watershed-Sendera and Circle C Pond Rehabilitation project, through the City's Vendor Connection web portal. Four bids were received and opened on November 30, 2017. Of the four bids received two bids were from MBE/WBE certified firms. Smith Contracting Company, Inc. submitted the lowest responsive bid of four bids received including an allowance of \$50,000:
