Federal Funds & Requirements

 The City of Austin receives four federal formula block grants from the U.S. Department of Housing and Urban Development (HUD), to help address affordable housing, community and economic development needs.











• Participating jurisdictions are required to affirmatively further fair housing choice, an objective of the Fair Housing Act.



What is the CAPER?

 At the end of each fiscal year, the City prepares a Consolidated Annual Performance and Evaluation Report (CAPER) that provides information to HUD and the public about accomplishments made possible with federal funding.



 The FY 2016-17 CAPER was submitted to HUD electronically on December 28, 2017 through the eCon Planning Suite, a feature of HUD's Integrated Disbursement and Information System. IDIS is the draw down and reporting system for formula block grants.










FY 2016-17 Expenditures

FY 2016-17 Households Served



The CAPER requires jurisdictions to report the number of clients served by race and ethnicity that are served by each funding source.


