**1. CALL TO ORDER**

- a. Chair Michael Jones called the meeting to order at 6:03 p.m.

**2. CITIZEN COMMUNICATION: GENERAL**

**3. NEW BUSINESS**

- a. Street Widths and Safety Discussions Update: Joe White (AFD), Laura Dierenfield (ATD), Christine Freundl (EDD), and Jim Adams (McCann Adams Studio) answered questions from Commissioners regarding the proposed local International Fire Code amendments and potential impacts on Mueller. Commission drafted a resolution to Council, recommendation number: (20171010-003A): Street Widths and Safety Impact of Proposed Fire Code Amendments on Mueller and Other Austin Neighborhoods. It was approved with edits on Commissioner Drennan's motion and Commissioner Hilliard's second on a 7-0 vote. Commissioners Luecke and Sokolic were absent.
- b. Capital Metro 2018 Service Changes Update: Commissioner David Neider provided an update on existing Capital Metro bus routes serving Mueller and proposed changes to be implemented in June 2018, pending Board approval.
- c. Mueller Development Update: Dee Desjardin with Catellus provided an overview of Mueller's development status, including information on upcoming new residential and mixed-use developments, upcoming events, and new businesses in the Town Center.

- a. Control Tower Update: Dee Desjardin provided a brief update on the status of the Control Tower historic zoning application. The Robert Mueller Municipal Airport (RMMA) Plan Implementation Advisory Commission (PIAC) nominated two Commissioners to attend the Historical Landmark Commission meeting as representatives of the RMMA PIAC.
