





Community Service Restitution

- ▣ Crews meet at DACC 7:30am, 7 days a week.
- ▣ Defendants engage in activities that give back to the community such as picking up trash, painting over graffiti and working at the DACC garden.
- ▣ Clients can receive credit for community service by engaging in case management activities like completing a coordinated assessment, attending appointments, applying for benefits, etc.





How Do Clients Become Engaged in Case Management Services?

- ▣ Arraignment Docket
- ▣ Walk-In Docket
- ▣ Walk-In (Non-Docket)
- ▣ On Call Case Manager Referrals
- ▣ Field Contacts
- ▣ Referrals from other agencies

Who is our targeted client?

- Our targeted client is our frequent offender population. A frequent offender is defined as a client with 25 or more cases with our court and at least one active case in the last 2 years.

- As of January 2018, DACCC had 365 frequent offenders.

Client Engagement

- ▣ Referrals
- ▣ Case Managers have a caseload of approximately 10-15 active clients
- ▣ DACC currently Case Manages about 57 clients
- ▣ 7 of the 8 Case Management team members have their MSSW or LPC



We currently have a waitlist of 115 clients who have requested our services.

Services Offered by DACCC

- ▣ If the offender agrees to engage in case management, the case manager completes a comprehensive initial assessment and treatment plan with the client.
- ▣ Plans are very individual for each client with the goal of stable housing.

- ▣ Detox
- ▣ 90 day residential treatment program
- ▣ Legal System Navigation
- ▣ Emergency Hygiene and Clothing
- ▣ ID Documents
- ▣ Emergency Shelter
- ▣ Transitional Housing
