# Goals

## Amend Title 8.—Parks and Recreation to:

- ❑ Clearly define terms used in relationship to the use of Alcohol in Parks
- ❑ Clearly state where alcohol is permitted
- ❑ Fairly and equitably regulate the use of alcohol possession within the park system
- ❑ Improve general park operations

# Research on Alcohol in Parks 7/15/17

# Round Table Discussions on the Issue

- ❑ PARD held round table discussions

- July 19, 2017: Technical focused, PARD Grounds, APD, Park Rangers
- July 25, 2017: Community Representatives

*Executive Committee of Austin Neighborhood Council; representatives from Galindo, Zilker, Govalle, University Hills Neighborhood Associations, Keep Austin Beautiful, Austin Parks Foundation, Pease Park Conservancy, Zilker Botanical Center Conservancy, Downtown Austin Alliance, and Vice Chair of the Parks Board*

- ❑ Among the Technical Group: Unanimous support to be consistent with prohibiting alcohol in parks.
- ❑ Among the Community Representatives: There was a split between the language of: “No alcohol in parks” versus “No public consumption of alcohol in parks.”

# Staff Recommendations

1. Staff recommendation is to prohibit alcohol on public recreation areas with some exceptions.
2. These exceptions include:
  - ❑ Rental facilities by permit (wedding venues, cultural centers, etc.)
  - ❑ Contracted concession sites
  - ❑ Designated event and picnic facilities by permit
  - ❑ Designated special event properties
  - ❑ Athletic fields except dugout and playfield
  - ❑ Rented campsites
  - ❑ Golf courses
  - ❑ Other areas as designated by the director

# 8-1-1 Definitions

## Current Definitions

- ▶ APPROVAL means a permit, reservation agreement, or other written document that evidences an authorization by the department.
- ▶ PUBLIC RECREATION AREA means a park, recreational facility, athletic field, building, swimming pool, playground, nature preserve, trail, dock, or greenbelt managed, maintained, or operated by the department or on the department's behalf.
- ▶ SPECIAL EVENT means an activity that anticipates 1,000 or more attendees and is conducted pursuant to an approval that allows for the exclusive use of all or part of the public recreation area for the activity.
- Clarification will be needed for: 1) Designated Event Facilities; 2) Playing field area and dugout, and 3) Designated Rental Sites

# 8-3-1 Alcoholic Beverages Prohibited

## Current Code Language

- ❑ Except as provided in Section 8-3-5, (Temporary Sales of Beverages and Food), a person may not knowingly sell, possess or consume an alcohol beverage in:
  - The fenced, enclosed area surrounding a swimming pool in a park or within 100 feet of an un-enclosed swimming pool in a park;
  - A recreation facility of adjacent outdoor area that is part of the recreation facility, including field, playground, parking lot, play slab or playscape;
  - All or part of a park or playground designated by the facility director as being an area in which the sale, possession or consumption of alcohol is prohibited;
  - The playing area or dugout area of an athletic field;
  - A school district playground area; or
  - A nature preserve.



## 8-3-1 Alcoholic Beverages Prohibited

# Impact of Proposed Changes

2013 Park List	2017 Proposed Park List
64% of individual park sites did not allow alcohol unless by permit from Director	73% of individual park sites would not allow alcohol unless by permit from Director

2013—36% of park sites allowed alcohol without a permit

2017—27% of park sites would allow alcohol with rental, special event, permit, etc.

# List Examples

- ▶ Alcohol Currently Not Allowed Locations List
- ▶ Rental areas would shift to areas where alcohol is allowed (highlighted yellow)
  - ▶ Caswell Tennis Center
  - ▶ Lamar Senior Activity Center
  - ▶ George Washington Carver Museum
- ▶ Areas not part of one of the main recommended categories would continue as limiting alcohol (red text)
  - ▶ Boggy Creek Greenbelt
  - ▶ Mayfield Nature Preserve
  - ▶ Northwest Pool

# List Examples (Comparison List)

- ▶ Areas that currently allow alcohol that would continue (highlighted yellow)
  - ▶ Auditorium Shores Town Lake Metro
  - ▶ Davis White NE District Park (Picnic Area)
- ▶ Areas that currently allow alcohol that would now be limited (red text)
  - ▶ Dittmar District Park
  - ▶ Duncan Neighborhood Park
  - ▶ Scofield Farms Neighborhood Park
