A. CALL TO ORDER

Chair Cofer called meeting to order at 5:12 p.m.

B. APPROVAL OF MINUTES

1. Approve the minutes of the Aquatic Master Plan Task Force meeting of November 14, 2017

Chair Cofer made a correction to the posted draft meeting minutes and corrected the day of the November meeting to Tuesday, November 14, 2017. (Posted minutes had the day stated incorrectly as Monday.) Task Force Member Rivera moved to approve the minutes of November 14, 2017 meeting with the noted correction.
