

## M/WBE Summary

Public notice was given for this solicitation, CLMC692 2018 Annual Asphalt Repair Contract 2018 IDIQ (north), through the City's Vendor Connection web portal. Three bids were received and opened on February 8, 2018. Of the three bids received two were from MBE/WBE certified firms. Alpha Paving Industries, LLC submitted the lowest responsive bid of three bids received:
