

M/WBE Summary

Public notice was given for this solicitation, CLMC693 Concrete and Asphalt Repair South IDIQ, through the City's Vendor Connection web portal. Four bids were received and opened on February 8, 2018. Of the four bids received three were from MBE/WBE certified firms. Smith Contracting Co, Inc. submitted the lowest responsive bid of four bids received:
