

M/WBE Summary

Public notice was given for this Request for Qualifications Solicitation CLMP240, 2018 Corridor Program Engineering Services Rotation List, through the City's Vendor Connection web portal. Thirty-one firms submitted qualifications statements and submittals were opened on January 30, 2018. Of the 31 submittals received, seven submittals were from MBE/WBE certified firms.

Participation subgoals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native/Asian; and 15.80% WBE. The recommended firms provided MBE/WBE Compliance Plans that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.
