Dear Chairwoman Galindo and Mr. Sadowsky:

Six Square - Austin's Black Cultural District (Six Square) supports the plans for renovation of Rosewood Courts Public Housing according to the current preservation principles that have been agreed to by the Housing Authority of the City of Austin (HACA), Preservation Austin, and Mid-Tex Mod. The preservation of 8 designated units, the inclusion of green space as an homage to Emancipation Park which will help to restore an important part of East Austin's African American history, and the increased accessibility and energy efficiency of all units is a great compromise that HACA has agreed to ensure Rosewood Courts incorporates modern innovation while also respecting the rich, historic past of Rosewood.

Rosewood Courts has been a staple historic site in East Austin and has provided affordable housing to Austenite's for 70 years. The historical significance of Rosewood Courts has shaped Texas history and United States national legislation, most notably with then Congressman Lyndon Johnson working for low-income housing subsidies in the late 1930's. The renovation and preservation of Rosewood Courts will allow the rich history of a turning point in Austin's history to be protected.

Six Square fully endorses the current plan as presented, but wishes to emphasize that one of our ongoing concerns is the repatriation rights of HACA residents currently residing in Rosewood Courts. This letter of support comes with the highest belief that HACA will abide by rules outlined in RAD Notice H 2016-17/PIH 2016-17 issued by HUD that was adopted to ensure fair and legal relocation guidance and the first right to return options, without new conditions and criteria for current residents who wish to return to Rosewood. We trust that HACA will provide adequate, safe, and comfortable housing for those who will be moved during this process.

We look forward to seeing the progress of HACA, Preservation Austin, and Mid-Tex Mod on the improvements to Rosewood Courts which we believe are a fair compromise that would benefit the greatest public good by providing more affordable housing in a

community that is continuing to face great development pressures and the rapid loss of middle and low-income families.


I write to express my support to the historic zoning of the proposed eight buildings at Rosewood Courts.

Holy Cross Catholic Church supports the preservation of eight of Rosewood Courts' original 25 buildings and the redevelopment of the remaining buildings at Rosewood Courts, so that the Housing Authority of the City of Austin (HACA) may improve quality of life for its current residents, while providing affordable housing opportunities to more families in need.

Holy Cross Catholic Church has adopted our neighboring Blackshear Elementary School and we have a reciprocal arrangement in support of each other. The future viability of East Austin requires that all ethnicities and all income levels that are residents of this area of Austin have housing that is affordable and high quality.

Dear Council Member Houston,

I am writing to express my support for the preservation of eight of Rosewood Court's original 25 buildings and the renovation of its buildings so that the Housing Authority of the City of Austin (HACA) may improve the quality of life for its current residents.

Our Lady of Guadalupe Catholic Church has long been involved in improving the lives of East Austin community residents through programs, services and Get Out The Vote efforts. In those efforts, it has become clear that the ability of people of all backgrounds and income levels to access housing that is both affordable and dignified is under threat in East Austin.

Built in 1939 by the Housing Authority of the City of Austin (HACA), the brick-walled buildings have antiquated electrical, plumbing and heating systems, and no air conditioning. Without insulation, the units are prohibitively hot in the summer and cold in the winter. Our understanding is that HACA has committed to replacing all 124 affordable units onsite, ensuring current residents have the first right to return to the property (once renovated) and preserving the historic character of the buildings

In previous years, members of our congregation learned from Rosewood Courts residents how the antiquated condition of the buildings negatively impacted adult health and impeded the ability for children to sleep and be school-ready the next morning. I support HACA's commitment to the creation of the eight-building historic zone while preserving the buildings and fully modernizing the interiors so that they are brought up to current code. Current residents should have the first priority in re-occupying the renovated units.

I encourage you to approve historic zoning of the proposed eight buildings at Rosewood Courts and to support the creation of expanded affordable housing, including added rental and homeownership units within reach of low-income families.

I ask that you support a plan for Rosewood Courts that responds to resident concerns, prioritizes their return and supports the ability for families with children to live and thrive in East Austin.
