Golf ATX Golf Courses

Hancock Golf Course est. 1899

- One of the oldest golf courses West of Mississippi
- Site of original Austin Country Club
- Became City operated in 1951



Lions Golf Course "Muni" est. 1934

- Recently added to the National Register of Historic Places
- Under lease from UT thru May 2019.

Morris Williams Golf Course est. 1964

• Major renovations in 2013





Jimmy Clay Golf Course est. 1974

- Shares club house with Roy Kizer
- Greens renovated in 2015





Grey Rock Golf & Tennis est. 1992

- Acquired by the City in June 2014
- Operated by Management Contract

Roy Kizer Golf Course est. 1994

- Site of former Waste Water Treatment plant
- Shares club house with Jimmy Clay
- Shared driving range and 3 hole short course




