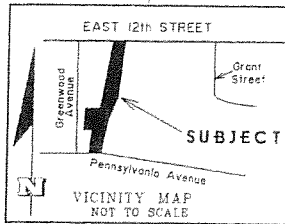
Site Location Map

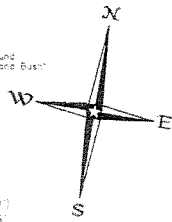
