

### ETHICS REVIEW COMMISSION

## REGULAR MEETING MINUTES Wednesday, March 21, 2018

The Ethics Review Commission ("Commission") convened in a regular meeting on Wednesday, March 21, 2018, at One Texas Center, 505 Barton Springs Road, Suite 500, in Austin, Texas. Chair Peter Einhorn called the meeting to order at 6:31 p.m.

Commissioners in attendance: Chair Peter Einhorn, Vice Chair Meagan Harding, Debra Danburg, Mary Kahle, Donna Beth McCormick, J. Michael Ohueri, Luis Soberon, Dennis Speight and Brian Thompson.

#### 1. EXECUTIVE SESSION

The Ethics Review Commission may announce it will go into Executive Session pursuant to Chapter 551 of the Texas Government Code to receive advice from legal counsel on any matters specifically listed on this agenda (Private Consultation with Attorney-Section 551.071).

The Commission may go into executive session to discuss legal issues related to:

A complaint filed on April 25, 2017, by Jason Hadavi, formerly Nathan Wiebe, Office of the City Auditor, against Margo Frasier alleging violation of City Code Chapter 2-7 (Ethics and Financial Disclosure), including witness and evidentiary issues related to the final hearing on the complaint.

The Commission went into executive session at 6:33 p.m. on the above matter, and returned at 6:52 p.m.

#### 2. FINAL HEARINGS

Discussion and possible action regarding the following:

The Commission will convene a final hearing under City Code Section 2-7-45 to consider a complaint filed on April 25, 2017, by Jason Hadavi, formerly Nathan Wiebe, Office of the City Auditor, against Margo Frasier alleging violation of City Code Chapter 2-7 (Ethics and Financial Disclosure).

At the conclusion of the final hearing, Commissioner Danburg made a motion to dismiss with a finding that no violation occurred, which was seconded by Commissioner McCormick. The motion passed on a vote of 7-2. Members voting aye: Chair Einhorn, Vice Chair Harding and Commissioners Danburg, McCormick, Ohueri, Speight and

Thompson. Members abstaining: Commissioners Kahle and Soberon. Secretary Robert "Ben" Stratmann was absent.

### 3. GENERAL CITIZEN COMMUNICATION

The first five speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda.

There were no speakers for general citizen communication.

Commissioners discussed inviting Charter Review Commission representatives to provide an update to the Ethics Review Commission at the next Ethics Review Commission meeting.
