Public notice was given for this solicitation CLMC649 FM 812 Landfill Letdown Repair through the City's Vendor Connection web portal. Three bids were received and opened on March 29, 2018. Of the three bids received none of the firms submitting were certified MBE/WBE. Smith Contracting Co. Inc. submitted the lowest responsive bid of three bids received including an allowance of \$35,000:
