# Regular Meeting 08 February 2011

# 1. APPROVAL OF MINUTES

The minutes from the 12/14/2010 meeting were approved with two minor changes: A small sentence structure change to Item 4a to read: "Mr. Derr, Assistant Director with the Austin Transportation Department, gave a summary of the policy goals to address the downtown parking shortage, resolving valet parking issues, increasing revenue, and reducing the City's carbon footprint. ATD will continue discussion with UTC/DC subcommittee and other stakeholders to ensure a comprehensive final recommendation to Council in February." Remove Item 5.e from the meeting minutes as this item was added in error. On Commissioner Holbrook-White motion, Commissioner Demling second, on a 6/0/1 vote, with Commissioner Lockler absent.

#### 3. NEW BUSINESS

A. Overview of the Sidewalk Projects to be funded through the 2010 Transportation Bond funds - Briefing

Ms. Diane Rice, Mr. Michael Curtis, and Director Howard Lazarus, with the Public Works Department gave a detailed presentation on the list of sidewalk projects that are in

the planning or construction stages, including explanation on the cost, funding source, and estimated time frame for completion. Some of these projects are being funded with the 2000, 2006, or 2010 Bond monies. One citizen addressed the Commission seeking an amendment to the proposed list of projects. **No Action Taken.** 

## 4. OLD BUSINESS

### a. Extended Parking Hours – Discussion and Possible Action

Mr. Gordon Derr, Assistant Director, and Mr. Steve Grassfield, Parking Enterprise Manager with the Austin Transportation Department gave a detailed presentation and answered questions on the proposed changes the department will be presenting to the City Council at the March 3<sup>rd</sup> meeting, to extend parking meter hours in the downtown area to include evening and Saturday hours. These changes are also being discussed by the Joint Subcommittee of the UTC and Downtown Commission. Commissioner MacKinnon acting as chair of the Subcommittee gave a progress report on the discussion and findings of the Subcommittee. Two citizens spoke against the proposed changes. **No Action Taken**.

# 5. STAFF AND COMMITTEE REPORTS

a) Approve Revised Bylaws relating to changes to the Boards and Commissions Standard Bylaws as Directed by City Council – Discussion and Possible Action

Staff presented the revised Bylaws with the changes that were requested by the City Clerk's Office at the direction of the City Council. A motion was made by Commissioner Holbrook-White to approve the bylaws as presented, Commissioner Blocker seconded. After discussion, Commissioner MacKinnon requested that the special events duties given to the UTC by Council be included as part of Article 2, Purpose and Duties section of the bylaws. The original motion was withdrawn by Commissioner Holbrook-White and a substitute motion was made by Chair Lanier to approve the bylaws and to request to the City Clerk to make any amendments as appropriate to reflect the special event duties that have been assigned to the Commission by Council. Commissioner MacKinnon seconded. The Bylaws were approved on a 6/0/1 vote with Commissioner Lockler absent.

Mr. Derr provided an update on three initiatives the Austin Transportation Department is working on: Low Speed Vehicles and Pedicab Ordinances to amend the Transportation Code and include these two categories in the Code; and a recommendation to Council proposing taxicab stands in certain areas of downtown in time for South by South West. One citizen spoke and expressed his concerns about some of the changes to the pedicab ordinance. **No Action Taken**.
