Executive Committee:

Comprehensive Planning Committee:

Planning Council Member Nicole Evans presented the final 2017 Austin Area HIV Needs Assessment report to the Council. The presentation focused on how to interpret results of the assessment.

Planning Council voted to approve the 2017 Austin Area HIV Needs Assessment Report (See Attachment 3) with the following changes:

- 1. Pg 5 word change from "African American" to "Black"
- 2. "Write in" changed to "write-in" where appropriate
- 3. Figure 15: Add * and spell out PTSD and ADD/ADHD
- 4. Pg 23 add "1" to the word "enrollment" in highlight box
- 5. Pg 5 correct name of HRAU to HIV Resources Administration Unit

In relation to the Needs Assessment Report, additional comments and next steps discussed include the following:

- Follow up/ Focus Group: With regard to co-occurring conditions, where is the unmet need? Does the unmet need fall within the scope of practice of primary care providers, or does the unmet need fall within the scope of specialty service providers?
- PrEP: Expressed interest in breaking down PrEP data by Age, Race/Ethnicity, and Gender
- Follow up/Focus Group: What type of transportation assistance would be most helpful? Transportation is a barrier, but what solutions work best for clients: gas cards? Ride shares? Bus passes? Van services? Etc.
- Terminology
 - o Discussion on terminology around race/ethnicity
 - o Terminology- DSHS is moving away from use of the term "AIDS", instead is using "Stage 3"
- Needs Assessment dissemination: Forum for clients to see results of survey- make this into a large event- it can serve as a place to recruit focus group participants and Planning Council members.
