

 ² All Street Reconstruction & Rehabilitation projects are completed and no funding remains. Awaiting possible 2018 Bond to address capital renewal projects for both Streets & Sidewalks.

2017 Sidewalk Spending



New Sidewalk Construction = 57,506 linear feet (~11 lane miles)

ADA Transition Plan (repairs, rehabilitation and replacement) = 28,063 linear feet (~5.3 lane miles)

Total FY17 Sidewalk spending, ~ \$8.4 million

*Funding for the ADA Transition Plan needs to grow as the network grows and sidewalks age. Therefore, PWD is requesting \$2.2 in FY19. The department's goal is to increase PWD TUF funding requests by \$1M/year for a total of \$5M by FY 22




