§ 2-1-21(C) ELIGIBILITY REQUIREMENTS AND REMOVAL.

A person who is registered or is required to register as a lobbyist under Chapter 4-8 (*Regulation of Lobbyists*) or who is employed by a person registered or required to register under that chapter is not eligible to serve on a board until the expiration of three years after the date that the person ceases to be registered, required to be registered, or employed by a person registered or required to register.

§ 4-8-4 PERSONS REQUIRED TO REGISTER.

Excepted as provided in 4-8-5 (Exceptions), a person must register with the city clerk if the person: (1) receives compensation of \$200 or more in a calendar quarter for lobbying; (2) receives reimbursement of \$200 or more in a calendar quarter for lobbying; (3) expends \$200 or more in a calendar quarter for lobbying; or (4) lobbies as the agent or employee of a person who: (a) receives compensation of \$200 or more in a calendar quarter for lobbying; (b) receives reimbursement of \$200 or more in a calendar quarter for lobbying; or (c) expends \$200 or more in a calendar quarter for lobbying.
