
# Architectural Barrier Removal Homeowner Program Achievements




# Home Owner Rehabilitation Loan Program Program Achievements


The purpose of the program is to assist homeowners in repairing major systems:

- Foundation, roof, plumbing, HVAC system, electrical work and other major interior and exterior repairs
- Bring the homes up to building code standards, making homes decent, safe, sanitary, and in good repair
- Up to \$75K per household for home repair and \$130K for reconstruction



# Holly Good Neighbor Program

The Holly Good Neighbor Program provides repairs and rehabilitation to owner-occupied homes closest to the Holly Power Plant. Austin Energy funds the program, administered by the Neighborhood Housing and Community Development Office (NHCD), and facilitated by the Austin Housing Finance Corporation (AHFC). Program addresses 29 Health & Safety Hazards. Provides up to \$20K in grant assistance; 100% MFI.




# General Obligation Bond Home Repair Program Achievements


The purpose of the program is to provide up to \$15,000 to homeowners to make home repairs to address 29 Health & Safety issues.

# Emergency Home Repair Program Achievements





# Down Payment Assistance Program Achievements





# Tenant Based Rental Assistance Program Achievements



The purpose of the program is to assist eligible, very low-income households to transition from homelessness to self-sufficiency by providing monthly rental and utilities assistance.




## Rent Availability Pilot Program Achievements

The purpose of the program is to provide short-term funding to formerly homeless individuals, with the expectation that the program's assistance will help to better position homeless individuals to be able to obtain future suitable long-term housing. The funds are to be used to fill the gap between the cost of rent at an eligible property and the amount of rental assistance or other income available to the client to be served.







# Senior Services Program Achievements



The purpose of the program is to provide bill payer services that help prevent and protect seniors from becoming victims of abuse, neglect, or financial exploitation.




# Youth Support Program Achievements




# Fair Housing and Tenant's Counseling Program Achievements






# Community Development Bank Program Achievements




# Micro-Enterprise Technical Assistance Program Achievements





# Rental Housing Development Assistance Program Achievements


# Acquisition and Development Program Achievements




