# **MINUTES**

### CALL TO ORDER: 6:10 P.M.

## 1. CITIZEN COMMUNICATION: GENERAL

Farah Muscadin, Interim Police Monitor, introduced herself to the Commission and provided an update on the status of the Office of the Police Monitor operations.

## 2. APPROVAL OF MINUTES

Commissioner Yoshida made a motion to approve the minutes from the Asian American Quality of Life Advisory Commission (AAQOLAC) meeting on April 17, 2018. Commissioner Radhakrishnan seconded the motion. The motion was approved on a 9-0-1 vote.

#### 3. OLD BUSINESS

- a. ACM Arellano provide an update on the AAQOL Final Report and next steps including a staff presentation at a future Health and Human Service Committee meeting. On behalf of the Commission, the Chair thanked Dr. Yuri Jang for her work on the report.
- b. Commissioner Yoshida made a motion to approve the proposed budget recommendations, seconded by Commissioner DasGupta. The Commission reviewed the proposed budget recommendations and approved the following amendments:

<u>Recommendation G-02</u>: Delete "city-funded". Motion by Commissioner Yoshida, seconded by Commissioner Debasree. Approved 11-0.

Recommendation G-04: Revise recommendation from: "AARC Nonprofit Capacity Funding – \$37,500 is requested to support the dual role of Agency oversight and Community Health Navigator (CHN) Program Management. PARD has \$37,500 in ongoing funding for this purpose, which would be matched with this action."

To: "AARC Nonprofit Capacity Funding – \$37,500 is requested to match PARD ongoing funding for AARC, Inc. nonprofit to continue the Nonprofit's role as:

- 1) Oversight of AARC, Inc. Nonprofit
- 2) Management of Community Health Navigator Program.

PARD has \$37,500 in ongoing funding for this purpose, which would be matched with this action."

Motion by Commissioner Stanton, seconded by Commissioner Radhakrishnan. Approved 11-0.

#### 5. NEW BUSINESS

- a. Commissioner Yoshida made a motion to nominate Commissioner Sethi to participate in the hiring process for the AARC Manager position, seconded by Commissioner DasGupta. Approved on an 11-0 vote.
- b. Commissioner Sethi made a motion to nominate Commissioners Yoshida, Saxena, and Cobalis to serve as the Commission representatives and Commissioners Stanton and Radhakrishnan as alternates with the authority to collaborate with other Quality of Life Commissions to develop joint 2019 budget recommendations. Seconded by Commissioner DasGupta. Approved on an 11-0 vote.
