

# Electric Utility Commission June 18, 2018 Minutes

The Electric Utility Commission (EUC) convened a regular meeting at 721 Barton Springs Road in Austin. Meeting called to order by Chair Ferchill at 6:00 pm. Commissioners Boyle, Hopkins, Osborne, Tuttle, Vaughan, and Weldon were also in attendance, with Hadden and Wray absent and two vacancies.

1. APPROVAL OF MINUTES – Approve minutes of the May 21, 2018 regular meeting. Motion (Osborne) to approve the minutes; seconded (Weldon); passed on a vote of 7-0, with Hadden and Wray absent and two vacancies.
