PROPOSAL

Demolish a ca. 1942 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled rock-veneered frame house with no front porch; single, double, and triple 1:1 fenestration.

RESEARCH

The house was built in 1942 by James V. and Bitha Walden, who rented it out for the first few years before moving in. James V. Walden was a driver, and later a carpenter. Bitha Walden was a cook at Austin State Hospital. They lived here from around 1945 until around 1947. From 1947 until his death in 1970, the house was the home of Jesse G. Lehmann and his wife, Addie. Jesse Lehmann was a maintenance man at Austin State School. Addie Lehmann was a cosmetologist at the same institution. After Addie passed away in 1964, Jesse continued to live here in his retirement. The house has had a series of renters since he passed away.

STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a very simple rock-veneered frame house with no architectural distinction.
- b. **Historical association.** The house was owned by two main families: a carpenter and his wife, who lived here in the 1940s, and a maintenance man and his wife, who lived here from the late 1940s until their deaths. There do not appear to be significant historical associations.
- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.



BIOGRAPHICAL NOTES:

James V. and Bitha Walden (ca. 1945 – ca. 1947)

James V. and Bitha Walden are listed in the 1940 U.S. Census as the renters of the house at 4012 Morningside Avenue. James V. Walden was 28, had been born in Texas, and was a fireman at the State Hospital. Bitha Walden was 31, had been born in Texas, and was a cook at the State Hospital. They had a daughter, Anita Joyce, 1, who had been born in Texas. The Waldens had lodgers: Floyd J. and Vera Velma Rutledge. Floyd J. Rutledge was 29, had been born in Oklahoma, and was a house painter. He lived in Ardmore, Oklahoma in 1935. Vera Velma Rutledge was 21, had been born in Texas, and had no occupation listed.

James Victor Walden died in Austin in 1982. He was born in 1912 in Texas, and was a contractor for residential and apartment properties.

Jesse G. and Adaline Lehmann (ca. 1947 – ca. 1970)

The 1930 U.S. Census shows J.G. and Addie Layman [sic] as the renters of a house in Florence, Williamson County, Texas. J.G. Lehmann was 42, had been born in Texas, and was a farmer. Addie Lehmann was also 42, had been born in Texas, and had no occupation listed. They had 4 children: son Lynn, 18, a college student; and daughters Lorena, 15, Aline, 13, and Maxine, 10. All the children had been born in Texas.

Addie Melvina Lehmann died in 1964 while living at this house. She was born in Lampasas County, Texas in 1886, and was a housewife.

His 1970 death certificate shows that Jesse Gaster Lehmann was living at this address at the time of his death. He was a widower who had been born in 1886 in Gonzales, Texas. He was a retired carpenter.

Funeral services for Mrs. Jesse G. (Addie) Lehmann, 77, of 1306 West 49th Street, will be held at Weed-Corley Funeral Home Tuesday at 4 p.m. Ministers Jimmy Gale of Georgetown and F. F. Conley of the Northside Church of Christ will officiate. Burial will be in Capital Memorial Park.

Pallbearers will be Franklin Johnson, Lenord Key, Mack Thompson, Claude Alexander, J. C. Clark and Halley Mott.

Mrs. Lehman died Sunday in a local hospital. She had been a resident of Austin for the past 16 years and was a member of the Northside Church of Christ. Before retirement in 1948 she had been a beautician instructor at the Austin State School.

She is survived by her husband; one son, Lynn Lehmann, Austin; four daughters, Mrs. Estelle Young, Lockhart; Mrs. Lorena Gattis, Georgetown; Mrs. Alene Gattis, Jonah; Mrs. Maxene Pogue, Austin; one brother W. G. Lynn, Los Angeles, Calif.; two sisters, Mrs. Olive Lehmann, Lampasas; Mrs. Zepha Walser, Austin; six grandchildren and six great grandchildren.
