HISTORIC LANDMARK COMMISSION JULY 23, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2018-0285 3110 GOVALLE AVENUE

PROPOSAL

Demolish a ca. 1927 house.

ARCHITECTURE

One-story, irregular-plan, stone-veneered house; what appears to be the original portion of the house is front-gabled with a shed-roofed carport to the right; single 1:1 fenestration. To the left of what appears to be the original part of the house is a stone-veneered one-story, side-gabled addition with a different pattern of stonework and modern, aluminum-framed windows.

RESEARCH

It is difficult to positively determine the age of the house as it was outside of the city limits at the time of its construction. City directory research and census records show members of the Erzkus family living in rural Travis County as early as 1910, but they also had a house in Austin on E. 6th Street. Fred Erzkus is the person most closely and significantly associated with this house. The 1927 city directory shows him living on E. 6th Street; the 1929 directory shows Fred, his father Max, and his brother Edward, living in Govalle. Judging from the architectural style of what appears to be the original part of the house, an estimated construction date of ca. 1927 seems appropriate, and is borne out by city directory listings, although there is less information than necessary to absolutely justify this construction date.

Fred Erzkus is listed as the owner and occupant of this house off-and-on from around 1927 until his death in 1954. He worked as a woodworker for Woodward Manufacturing Company, an auto body manufacturer (when auto bodies were still crafted out of wood), and later a furniture manufacturer. His last occupation appears to be as a service station attendant. Since his death, the house has been used as a rental property, and a large addition constructed.

STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a stone-veneered late 1920s cottage with little architectural distinction, and a large stone-veneered addition that appears to have been constructed in the 1960s. The house does not reflect any significant architectural distinction.
- b. **Historical association**. The house was the home of members of the Erzkus family, who moved into Austin from Fayette County around the turn of the century. Max Erzkus was a truck gardener; his son Fred, who has the longest period of occupancy of this house, was a woodworker. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.

- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, preserving the original stone section of the house over the newer addition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history for archiving at the Austin History Center. The house does not appear to meet the criteria for individual designation as a historic landmark.



1927 Unknown

Fred Erzkus is listed at 1313 E. 6th Street and was employed by Woodward Body

Works. No other members of the Erzkus family are listed at Govalle.

The 1924 city directory shows Fred Erzkus as an employee of Woodward Body Works. He lived at 311 E. 15th Street, the home of his uncle and aunt, Hugo and Bettie Erzkus.

The 1922 directory shows Fred Erzkus living at 1313 E. 6th Street; he was a mechanic for Woodward Manufacturing Company. Hugo E., and Bettie Erzkus are still listed at 311 E. 15th Street; neither had an occupation shown.,

BIOGRAPHICAL NOTES

Fred Erzkus (ca. 1927 – ca. 1954)

The 1910 U.S. Census shows Fred Erzkus living in the home of his parents in Justice Precinct 3 in Travis County. Fred had no occupation listed. Max Erzkus was a truck farmer.

His 1918 World War I draft registration card shows Fred Erzkus as living on Route 1 in Travis County. He was a gardener. His father was his nearest relative, and lived at 1313 E. 6th Street in Austin. Fred Erzkus was of medium height with a stout build. He had gray eyes and brown hair.

Fred Erzkus appears at as the 21-year old son of Max and Lena Erzkus in the 1920 U.S. Census for Justice Precinct 3 of Travis County. Fred had a younger brother, Eddie, 17. Max Erzkus was a trucker and farmer. Fred Erzkus was a laborer in an oil field. Eddie Erzkus had no occupation listed.

The 1930 U.S. Census shows Fred Erzkus as the 31-year old son of Max Erzkus, who owned a house worth \$2,000 on RFD Route 1 in Travis County. Fred was born in Texas and was a millworker. His father, Max Erzkus, 60, had been born in Texas to Prussian-born parents, and was a gardener Fred had a younger brother, Edward, 27, who was also a gardener.

Fred Erzkus is listed in the 1940 U.S. Census as the owner of a house worth \$450 in Govalle. He was 41, had been born in Texas, and was a mill operator. He was single.

His 1954 death certificate shows that Fred Erzkus was born in 1895 in Flatonia, Texas, and was a widower. He was a service station attendant and was living at 1011 Tillery Street at the time of his death.

THE DEAD

ERZKUS-Funeral services Max Erzkus, 82, were to be held Monday at 3 p. m. from the Meeks-Hyltin Funeral home with the Rev. Fred W. Kern, pastor of the First English Lutheran church. officiating. Pallbearers will Rudy Henninger, Ben Pounds, Rob-ert Delzell, Marshall Crow, W. T. Sanders and W. G. Ross, Burial wos to be in the Oakwood cemetery.

Surviving Mr. Erzkus are two sons, Fred Erzkus and Edwin Erzkus, both of Austin; two sisters, Mrs. Dora Hildebrandt of Westhoff and Mrs. Lena Creutzfeldt of Austin, and one brother, Hugo Erzkus of Austin.

Mystery Death Under Scutiny

Investigation of the death of Ed Erzkus, whose body was found alongside the Southern Pacific railroad tracks near Airport Boulevard Tuesday, was being continued Wednesday.

Justice of the Peace Tom Johnson said special agents of the railroad and Deputy Robert Sjoberg would be given plenty of time for a full investigation of the death before he rendered his verdict.

Erzkus, middle-aged resident of the Rogers Hill community, was found dead alongside the tracks 238 feet west of the overpass on Airport Boulevard Tuesday morning. He apparently had not been hit by a train.

His body was discovered by the engineer of the Southern Pacific passenger train coming in from Houston at 5:10 a.m.

Johnson said when he examined the body around 6 a.m., it appeared that Erzkus had been dead only a short time.

Erzkus is survived by one son, Ed Erzkus Jr., and a brother, Fred Erzkus, both of Austin.

Funeral arrangements were incomplete Wednesday since an administrator was to be appointed since-Erzkus' only son is a minor.
