**Amendment:** C20-2018-002 Administrative Services Use

<u>Description:</u> Consider an ordinance to amend Austin City Code Section 25-2-491 *Permitted, Conditional, and Prohibited Uses* to add Administrative Services as a permitted use in the Downtown Mixed Use (DMU) and the Central Business District (CBD) zoning districts and amend Austin City Code Section 25-2-6 (B) (1) to add "federal, state, county, and city courthouses" as uses expressly enumerated as being Administrative Services.

### Summary of proposed code amendment

- Amends the Permitted Uses chart of Section 25-2-491 Permitted, Conditional, and Prohibited Uses to make Administrative Services permitted uses in the Downtown Mixed Use (DMU) and the Central Business District (CBD) zoning districts.
- Amend Code Section 25-2-6 (B) (1) Civic Uses Described to specifically add "courthouses" to the list of uses that are expressly deemed to be administrative services.

**Background:** Initiated by Planning Commission of July 24, 2018.

In cooperation with Travis County, this amendment was initiated by the Planning Commission on July 24, 2018. To accommodate the timing of construction of the new County Courthouse, staff is processing the commission initiated request as soon as possible to ensure no delay is occurred by the County. Planning Commission will consider this amendment at their August 14 meeting.

# § 25-2-6 CIVIC USES DESCRIBED.

- (A) Civic uses include the performance of utility, educational, recreational, cultural, medical, protective, and governmental functions, and other uses that are strongly vested with public or social importance.
- (B) Civic use classifications are described as follows:
  - (1) ADMINISTRATIVE SERVICES use is the use of a site for provision of offices or administrative, clerical, or public contact services, together with incidental storage and maintenance of necessary vehicles. This use includes federal, state, county, and city offices and courthouses.
