### **Additional Backup Information:**

The North Shoal Creek Neighborhood Plan is the second neighborhood plan initiated after the adoption of the Imagine Austin Comprehensive Plan. The neighborhood planning process is a community-driven process that works within the framework of Imagine Austin to address the goals of the comprehensive plan and the neighborhood planning area at the neighborhood scale.

PAZ staff began meeting with stakeholders in May 2016 and held the first workshop in October 2016. Through 2017, seven workshops and other community meetings were held with the community. Staff also incorporated input collected through online and mail surveys, as well as attending neighborhood association meetings.

The plan contains vision statements and policies for each character area of the neighborhood. The plan includes goals, policies, and actions related to transportation, land use, environment, health, safety, and community interaction.
