

## M/WBE Summary

Participation subgoals stated in the solicitation were 1.66% African American; 2.94% Hispanic; 2.79% Native/Asian; 3.80% WBE. The recommended firm provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
