### I. PART A & MAI GRANTS ADMINISTRATION/ MANAGEMENT UPDATE

### A. <u>Due Date for Grant Application</u>

The FY 2018 Ryan White HIV/AIDS Program Part A Notice of Funding Opportunity (NOFO) for the 52 eligible jurisdictions was released on August 30, 2017 with a due date of **October 30, 2017**. The Division of Metropolitan HIV/AIDS Programs will be hosted a technical assistance webinar on the NOFO on September 12, 2017. The purpose of the webinar was to assist potential applicants in preparing applications that address the requirements of the NOFO. AA and PC staff are currently preparing the application.

## B. <u>Ryan White FY17 Part A Overall Expenditure Summary (March 2017 to</u> <u>February 2018)</u>

The FY17 Part A overall expenditure estimates are shown below. Approximately forty one percent (41%) of funds have been billed through <u>August of 2017</u>. Table 1 below shows the overall expenditure summary. Monthly <u>service category</u> expenditures are provided to the Allocation Committee.

- In preparation for the RSR, webinars and data clean-up are in progress, and provider training is being scheduled.
