BE IT RESOLVED that the Hispanic/Latino Quality of Life Resource Advisory Commission requests that the Austin City Council: At the August 28 Hispanic/Latino Quality of Life Commission meeting, commissioners clarified their budget recommendation for a Community Engagement FTE supporting the Restore Rundberg initiative. During this meeting, commissioners heard from Monica Guzman (Restore Rundberg Chair) and Ann Teich (Restore Rundberg Vice-Chair), who recommended that the position be placed within the Communications and Public Information Office (CPIO)/Community Engagement Division. Their reasoning was to provide a citywide perspective on engagement across all departments and services.
