## **Environmental Commission**

#### (Official Name of Board or Commission)

### The Board/Commission mission statement (per the City Code) is:

Per Section 2-1-144(F) of the City Code, the Environmental Commission may:

- (1) review and analyze the policies relating to the environmental quality of the city;
- (2) act as an advisory board to the city council, the city manager, and the department in their efforts to oversee the protection and integrity of the natural environment;
- (3) promote growth management and land use planning, minimize degradation of water resources, protect downstream areas, and promote recreation opportunities and environmental awareness; and
- (4) advise and recommend on any issue which the commission determines necessary or advisable for the enhancement and stewardship of the urban forest both public and private.
- (G) The Environmental Commission shall:
- (1) assist the city council, the city manager, and the department in studying, promoting and enforcing environmental protection policies to assure the health, safety, welfare and quality of life of all citizens within the City's incorporated boundaries as well as those within its extraterritorial jurisdiction where the boundaries apply; and
- (2) oversee the development and implementation of a comprehensive plan for the planting, maintenance, and replacement of trees in the City's jurisdiction, and revise the plan as necessary. When a portion of the plan has been developed and established, it shall be submitted to the city council for adoption before implementation.
- (H) The Environmental Commission shall advise the city council, the city manager, and the department concerning policies, projects, and programs that affect the quality of life or have the potential to affect the environment, including those that relate to or affect: (1) water quality: (a) watershed protection; (b) urban runoff; (c) innovative wastewater treatment; (d) regional wastewater treatment; (e) improvement and protection of the

Colorado River and the Edwards Aquifer; and (f) wastewater irrigation;

- (2) growth management and land use planning: (a) municipal utility district review; (b) capital improvement project review; and (c) the comprehensive plan;
- (3) construction controls for erosion and sedimentation;
- (4) City environmental policies regarding monitoring and enforcement;
- (5) solid waste disposal plan alternatives;
- (6) watershed protection: (a) flood control; (b) erosion control; (c) water quality; and (d) utility management;
- (7) roadway planning;
- (8) beautification;
- (9) recreation resources;
- (10 public education on environmental matters;
- (11) hazardous waste materials management;
- (12) revegetation and landscaping;
- (13) air quality;
- (14) noise abatement; and
- (15) all matters pertaining to the City's urban forest, including public and private trees.
- (I) The Environmental Commission shall:
- (1) review all variances to requirements for water quality protection;
- (2) review the monitoring of storm water runoff in developed and undeveloped areas;
- (3) review the efficiency of existing and proposed structural and nonstructural water quality controls;
- (4) periodically review the effectiveness of Chapter 25-4 (Subdivision);
- (5) review waste treatment permits within the city's extraterritorial jurisdiction;
- (6) review programs and policies for flood control, erosion control, and water quality;
- (7) review capital improvement projects;
- (8) review municipal utility district proposals and amendments;
- (9) review roadway plan amendments;
- (10) recommend urban runoff standards; and
- (11) review the environmental elements of planned unit developments.
- (J) The Environmental Commission may recommend and initiate, with the advice and consent of the city council, specific project studies concerning any of the matters described in Subsections (H) and (I), or any other related environmental or urban forestry issue.
- (K) The commission shall make reports and recommendations for standards and criteria concerning any of the matters described in Subsections (H) and (I), or any other related environmental or urban forestry issue.
- (L) The commission shall promote close cooperation between the City and all private citizens, institutions, and agencies interested in or conducting natural resource, environmental, and urban forestry activities, so that all similar activities within the city may be coordinated to secure the greatest public welfare.

The revision of the three drafts of CodeNEXT took a significant amount of time and effort by the Environmental Commission. CodeNEXT was discussed and considered at fifteen subcommittee meetings, in addition to numerous working group meetings of the Commission. It was considered at the Environmental Commission fourteen times in order to respond to the questions and concerns of citizens and stakeholders in the community. The Commission passed fifteen recommendations on CodeNEXT throughout the draft revision process.

The final Environmental Commission recommendations on CodeNEXT included recommendations on:

- the alignment of City initiatives with CodeNEXT for collective input
- interim regulations addressing expected changes to the 100-year floodplain
- requesting a staffing analysis in conjunction with CodeNEXT
- environmental regulations including water quality and Green Stormwater Infrastructure (GSI), construction in urban watersheds, floodplain variances, trees, landscape, open space and parkland, Planned Unit Developments, and light and sound pollution.
- street tree regulations
- economic displacement as an environmental issue
- drainage regulations for commercial and multi-family redevelopments
- drainage regulations for single family residential and missing middle/residential heavy developments
- CodeNEXT addenda and Planning Commission recommendations regarding civic open space
- CodeNEXT addenda regarding tree issues
- The Planning Commission Recommendation regarding minimum development potential.

# 2. Determine if the board's actions throughout the year comply with the mission statement.

All actions taken by the Environmental Commission were in furtherance of the Commission's mission statement. Actions taken by the Commission in furtherance of the mission statement included the recommendation to rename the Slaughter Creek Management Unit to the Mary Gay Maxwell Management Unit in recognition of Mary Gay Maxwell's legacy as a long time Environmental Commissioner and volunteer with the Water Quality Protection Land stewards.

Additionally, the Environmental Commission provided a recommendation to Council regarding an ordinance authorizing execution of the first amendment to a settlement agreement relating to the development of property located at 6409 City Park Road (Champion Tract); amending Ordinance Number 960613-J; modifying provisions of the Lake Austin Watershed Regulations in Ordinance 840301-F; and modifying provisions of the Hill Country Roadway Regulations in City Code Chapter 25-2.

The Commission also made a recommendation to remove Roy G. Guerrero Park from the list of potential sites for the Major League Soccer Stadium to protect the park from private development, protect open space and the environment, and to consider additional funding sources, including bonds, to repair and maintain Roy G. Guerrero Park.

Further, The attached spreadsheet will validate the amount of work the Environmental Commission completed this past year reviewing and implementing recommendations to Council regarding variances, waivers, code amendments and stream buffers in compliance with the mission statement.
