- c. Discussion and possible action regarding Budget
  - i. Motion by Commissioner Lopez Aguilar to support the creation of a master plan to design and develop the 5<sup>th</sup> Street Mexican American Heritage Corridor; from Republic Park to East 5<sup>th</sup> Street to Saltillo Plaza with the MexicArte Museum as the central anchor. This is one-time funding of \$250,000. Second by Commissioner Maga Rojas. Motion passed unanimously.
  - ii. Motion by Commissioner Lopez Aguilar to accept changes the memo in regards to the letter of support for the MACC and MexicArte; specifically changing the amount of requested funding from \$15 million to \$37 million and correcting the date. Second by Commissioner Maga Rojas. Motion passed unanimously.
  - iii. Motion by Commissioner Llanes Pulido to support an organization that teaches Latina girls ages 9 to 18 in 21<sup>st</sup> century skills in production, coding, virtual augmented reality generation, robotics 3D printing as well as transcendent soft skills in writing, social emotional learning and leadership that round out Austin's largest youth population for the city's most lucrative industries including media and technology for the amount of \$85,000 in ongoing funding. Second by Commissioner Flay. Motion passed unanimously.
  - iv. Motion by Commissioner Llanes Pulido to recommend \$50,000 in ongoing funding for capacity building for an arts advocacy organization to improve the prospects of Austin's Latino arts community through research, education, advocacy and programming. Second by Commissioner Maga Rojas. Motion passed unanimously.
  - v. Motion by Commissioner Lopez Aguilar to support the Commission on Seniors budget recommendations from May 9<sup>th</sup> to include improving transportation; assets map for the age friendly needs (marketing and

maintenance); health assessments including mental health; expansion and coordination for senior transportation including drivers and three accessible vans; one FTE for senior programs. Departments need to determine the amount necessary to fulfill such needs. Second by Commissioner Llanes Pulido. Motion passed unanimously.
