**B. APPROVAL OF MINUTES**

**1. Approve the minutes of the Land, Facilities and Programs Committee meeting of January 8, 2018.**

Committee Member Donovan made a motion to approve the minutes of the Land, Facilities and Programs Committee regular meeting of January 8, 2018. Committee Member Mann seconded the motion. The motion carried on a vote of 4-0 with Committee member Morgan absent.

**D. NEW BUSINESS: DISCUSSION AND POSSIBLE ACTION ITEMS**

**2. Make a recommendation to the Parks and Recreation Board for approval of Permanent Use (514 sq. ft.), of parkland not to exceed 450 Calendar days on parkland located at 5100 E 51<sup>st</sup> St. (Little Walnut Creek Greenbelt). Total Mitigation value is \$1,420.**

Greg Montes, Park Development Coordinator, Park and Recreation Department, corrected the total mitigation value incorrectly stated in the agenda to the amount of \$2,821

Eric Bailey, Project Management Supervisor, Public Works Department, made a presentation to the Committee and answered Committee Members' questions.

Committee Member Donovan made a motion to approve this item and move it to the full Board for review. Committee Member Ward seconded to motion. Motion carried on a vote of 4-0 with Committee member Morgan absent.
