Thanks for rolling out the website you showed us last night. I am very excited about it and think it will be a wonderful tool for everyone!

Would you be so kind to forward me a link to the Beta page to look at more closely. I understand it is a work in progress and will be happy keep it internal and to give any feedback to help the process.

Additionally, I am not sure why communications broke down on the interpretation case information request last night. I think the conversation got stuck in historical data instead of future cases.

What William and others were requesting is to be notified of any future challenges made to a determination rendered by the department. In other words, when a formal request for an interpretation case is initially made, before any action has been taken by COA. Prior to anyone deciding it is ripe, has standing, etc. In essence, when it comes through the front door. Local Government Code say that those appeals should go directly to the chair of the BOA. That is not happening and he was asking for that to happen.

At present, interpretation cases are being prefiltered before BOA ever hears about them, if they do at all.. We have no idea of those that we are not seeing. He was using the Life Austin case as an example. Hope that helps. William assured me this will be on the August agenda for further discussion if you care to attend.
