## 7. FY 19 RYAN WHITE PART A RESOURCE ALLOCATION.

- a. Jeannie Nelson, AIDS Services of Austin (ASA) spoke on dental health to the committee. She discussed how cost per visit has gone up 17% this year and patient acuity continues to increase. She advocated that decreased funding would be an issue for this service, and encouraged an increase in spending.
- b. Alberto Barragan, AIDS Services of Austin discussed limited funding for Outreach. This service benefits homeless and individuals recently released from jail getting into and accessing services. His program struggles with limited staffing and if funding is not increased there will be less ability to reach clients. No other funding services are available at this time.
- c. Melissa Rios, AIDS Services of Austin discussed medical and non-medical case managers and advocated for increasing funding.
- d. Committee members discussed their allocation recommendations and logic supporting recommendations. Issues raised for consideration include:
  - i. Listening to the consumer's feedback in the needs assessment.
  - ii. Use of own personal experience accessing services.
  - iii. Referencing the data provided by support staff such as expenditures by service category.
- e. Please see Appendix A for recommendation for adoption the FY19 Ryan White Part A Resource Allocation. All service categories and MAI was approved on Committee Member Barry Waller motion and Committee Member Dale Thele second on a 3-0 vote. Committee Member Roger Baltazar was absent.

## 8. FY19 RYAN WHITE PART A INCREASE / DECREASE PLAN

- a. Committee recommended adding Food Bank and Oral Health as services that will not be funded below FY18 funding level at time of final award for FY19.
- b. Psychosocial Support Services was removed from the list of services that will not be funded below FY18 funding level at time of final award for FY19.
- c. Recommendation for adoption by Planning Council the FY19 Ryan White Part A Increase/Decrease plan with the above corrections was approved on Committee Member Barry Waller motion, Committee Member Dale Thele second on a 3-0 vote. Committee Member Roger Baltazar was absent.
