HISTORIC LANDMARK COMMISSION SEPTEMBER 24, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2018-0442 506 WALSH STREET

PROPOSAL

Relocate a ca. 1936 house to outside the city.

ARCHITECTURE

One-story, roughly rectangular-plan, cross-gabled frame house with elements of Tudor Revival detailing; round-arched doorway under a gabled entry hood; carport to the left of the entry; single and paired 1:1 fenestration.

RESEARCH

Staff believes the current house was built in 1936. The 1935 Sanborn map shows the earlier house on this site, which dates from the turn of the century; the current house appears on the 1961 Sanborn map.

This was a rental property, but had a long-term tenant: Alton L. McNatt and his wife, Orene, who lived here from 1940 until 1961, when they bought a house in French Place. Both Alton and Orene McNatt were from Montague County, Texas, near Bowie, and when Alton retired, they left Austin and moved back to Bowie where they are both buried. Alton McNatt was a section chief for the IRS; Orene McNatt was an office manager at St. David's Hospital. She was also involved in the Sunshine Camp in Zilker Park.

STAFF COMMENTS

The house was listed with no priority for research in the Comprehensive Cultural Resources Survey (1984).

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:


- a. **Architecture.** The house is a 1930s cottage; its only architectural distinction is the round-arched doorway. The house does not qualify as a landmark under the architecture criterion.
- b. **Historical association**. The house was rented for just over 20 years by a section chief for the IRS and his wife, who was an office manager for St. David's Hospital. There do not appear to be any significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for


archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

Alton and Orene McNatt (ca. 1940 – ca. 1961)

Unknown

The 1940 U.S. Census shows Alton and Orene McNatt as the renters of this house. Alton McNatt was 28, had been born in Texas, and was a clerk for the Internal Revenue Service. Orene McNatt was also 28, had been born in Texas, and had no occupation listed. They had a daughter, Barbara J., 6, who had been born in Texas. The McNatts had lived in Montague, Texas in 1935. They had two lodgers: Muriel Swarner, 28, who had been born in Iowa., and was a stenographer for an auto insurance firm, and Ann Gift, 24, who had been born in

California, and was a receptionist for a photographer. Muriel Swarner lived in Des Moines, Iowa in 1935; Ann Gift lived in Mill Valley, California in 1935.

The 1930 U.S. Census shows Alton McNatt as the 18-year old son of John C. and Agnes McNatt, who owned their home in Bowie, Texas. Alton had no occupation listed. He had a younger brother, Paul. His father, John C. McNatt, was the Texas-born manager of a cotton oil mill.

Deed records show that Alton and Orene McNatt purchased property in French Place in 1961. They moved back to Montague County, Texas later in life. Alton Leroy McNatt died in 1972 in Bowie, Texas. He was born in 1911 in Stoneburg, Texas and was retired from the Internal Revenue Service. Nanny Orene McNatt died in Bowie in 1986.



McNatt lived in Bowie at the time of his death. He moved from Austin in 1968.


