

EARLY CHILDHOOD COUNCIL MINUTES

REGULAR MEETING Wednesday, August 8, 2018

The Early Childhood Council (ECC) convened in a regular meeting on Wednesday, August 8, 2018, at City Hall, in Austin, Texas.

Board Members in Attendance: Chair Larry Elsner, Raul Alvarez, Mary Jane Burson-Polston, Serena Hill, Aletha Huston, Rhonda Paver, Monica Sanchez, and Sebastian Wren.

Staff in Attendance: Austin Public Health Department (APH) staff –Laura Williamson and Cynthia Gamez.

Chair Elsner called the Board Meeting to order at 9:09am.

- 1. INTRODUCTIONS: ECC members, guests, and presenters introduced themselves.
- 2. DISCLOSURE OF CONFLICT OF INTEREST: None

- 4. APROVAL OF MINUTES: Member Huston moved to approve the May 9, 2018 Regular Meeting Minutes and Member Alvarez seconded. Minutes were approved by a vote of 8-0.

5. PRESENTATIONS:

- a) Proposed fiscal year 2019 Austin Public Health (APH) budget- APH budget staff
 - i. Chris Riley, Financial Manager for Austin Public Health presented a general overview of the City Manager's proposed budget for Austin Public Health including sources of funding, where funds are proposed for investment, notable changes, and new investments. The total proposed budget for the department is \$113.6 million, including \$79.3 million in from the General Fund and \$34.2 million from various grants. The proposed budget includes \$128,000 for investments of startup costs for Pre-K 3 classrooms and \$75,000 for a consultant to explore incentives and public private partnerships for quality child care; both of these items were endorsed and recommended by the Early Childhood Council. All budget items are subject to changes and pending City Council approval.
- b) Success By Six School Readiness Action Plan (SRAP) 2019-2023
 - i. Sue Carpenter, United Way for Greater Austin presented, and

outlined the goal of the SRAP to support and advocate for young children. The first version of the SRAP was published for 2012-2015, the second version was published for 2015-2018, and the community development process is nearing completion for the next iteration which will span 2019-2023. The SRAP is a community plan with broad ownership and engagement. General overview was provided regarding partnerships and progress to date regarding services, coalition building, data collection. Three requests included 1) ECC representation to serve in key leadership role in activation of new plan; 2) ECC participation requested in final SRAP planning efforts; and 3) ECC endorsement of SRAP 3.0 was encouraged.
