Authorize award and execution of a multi-term contract with **Thirkettle Corporation D/B/A Aqua-Metric Sales Company**, to provide fire service type meters, for up to five years for a total contract amount not to exceed \$1,525,000.

Amount and Source of Funding

Funding in the amount of \$279,583 available in the Fiscal Year 2018-2019 Operating Budget of Austin Water. Funding for the remaining contract term is contingent upon available funding in future budgets.

Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) 2200 GLB1007 for these goods. The solicitation issued on July 23, 2018 and it closed on August 9, 2018. Of the four offers received, the recommended contractor submitted the lowest responsive offer.

MBE/WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established.		

The contract is to provide fire service type meters for Austin Water. The line maintenance, construction, and field service divisions use these meters in water service installations and replacements of broken meters. These are water meters that are specifically designed for the commercial properties or multi-family dwellings that have fire sprinkler systems installed. The meters are equipped with a strainer to prevent water meter clogs and provide the building with a constant flow if the fire sprinkler system is activated. The meters are necessary to meter usage and flow within the City's water distribution system.

This contract will replace a contract which expired on October 13, 2018. The requested authorization amount for the contract were determined using departmental estimates and historical spending. The variable demand of required meters and the lead time to receive the necessary items makes it essential to maintain stock in the warehouse. The recommended contractor is not the current provider for these goods.
